



## FAQs 1.03 - Grant VA Program

### What Is the Length of the Grant Virtual Assistant (Grant VA) Online Course?

The length it takes to complete the online class depends on you. You could complete the course within a few weeks. Or, you could take more time. Everything is based on you and your schedule and availability. Upon registration, you will be contacted within 48-72 hours during work days (Monday-Friday) by an experienced Grant VA. You can schedule your “onboarding” and “check in” dates/times.

### Who Is Eligible to Enroll in a Grant VA Program?

You are eligible to enroll in a Grant VA Program IF you work for, or are interested in helping or being employed by, one or more agencies who are grant-eligible:

- U.S. Nonprofits: 1,036,255 public charities (source: National Center for Charitable Statistics)
- U.S. Schools: 98,817 public schools, 33,366 private schools, 7,021 colleges/universities (source: U.S. Department of Education)
- U.S. Local Government Agencies: 89,004 (source: U.S. Census)
- U.S. Hospitals: 5,686 (source: American Hospital Association)

### Do I have to be trained as a Virtual Assistant (VA) first?

No! If you are trained as a Virtual Assistant (VA), that is great! However, if you have not been trained as a VA, the Grant VA Program will pick up the cost for you to enroll in a Work From Home as a Virtual Assistant online course with 3 hours of on-demand videos. This course is designed for people who want to start their own small business and work from a home office. It is perfect for individuals who have not received any formal training as a VA.



## What Will I Learn in the Grant VA Online Class? From whom?

There are over 100,000 grant-makers (private and public) in the U.S. Over the years, experts have discovered that most funders want to see similar elements in proposals they fund: 1) summary, 2) agency introduction, 3) need/problem statement, 4) outcomes/objectives, 5) project methods or design, 6) project evaluation in reaching outcomes/goals, 7) future funding after the grant is gone, and 8) an itemized budget. Interestingly, the Federal government also recommends these as the eight basic components to creating solid federal grant proposals.

## Why Is It Called "Grant VA"?

When our first course was approved and offered in 2001 by the University and Community College System of Nevada for 2 college credits (30 hours of instruction), it was called "Grant 101" or "GRNT 101." In 2007, the Grant Professional Certification Institute (GPCI) began offering the GPC exam as an independently administered assessment of skills needed by a "generalist grant professional." So, the course was renamed "Grant Professional 101." In 2021, a Grant VA version was designed with a hybrid module training by video



online along with supplemental textbooks plus an accountability partner for ongoing support with a specific focus on Grant VAs.

### On What Standards, If Any, Is the Grant VA Class Based?

Unlike most semester-long classes, in as few as two weeks, the Grant VA online class introduces you to all nine validated competencies developed by the accredited Grant Professionals Certification Institute (GPCI) that is part of the Grant Professional Certificate (GPC) exam:

- Competency 01 - Knowledge of how to research, identify, and match funding resources to meet specific needs (15%)
- Competency 02 - Knowledge of organizational development as it pertains to grant seeking (06-09) (10%)
- Competency 03 - Knowledge of strategies for effective program and project design and development (20%)
- Competency 04 - Knowledge of how to craft, construct, and submit an effective grant application (25%)
- Competency 05 - Knowledge of post-award grant management practices sufficient to inform effective grant design and development (7%)
- Competency 06 - Knowledge of nationally recognized standards of ethical practice by grant developers (10%)
- Competency 07 - Knowledge of practices and services that raise the level of professionalism of grant developers (5%)
- Competency 08 - Knowledge of methods and strategies that cultivate and maintain relationships between fund-seeking and recipient organizations and funders (8%)
- Competency 09 - Ability to write a convincing case for funding (20%)

## **How Can I Become Grant Professional Certified (GPC)?**

Grant VA prepares you by introducing you to the nine core GPCI competencies needed to pass your GPC exam and gain your GPC credential. The GPC exam is offered independently through the Grant Professionals Certification Institute (GPCI).

To be eligible to take the GPC exam, you must have completed at least 5 successful grant proposals over the past 7 years. You also must have a minimum of 3-5 years of professional experience in the grants field within the past 5-7 years. Eligibility is based on education, professional experience, professional practices and community involvement.

Graduates of the Grant VA class are encouraged to study for and take the GPC exam as soon as they are eligible. To help prepare, graduates are invited to take the Grants Academy's advanced GPC Exam Prep class online when they are eligible and ready to take the GPC Exam!

## **Is the Grant Professional Certified (GPC) Credential Accredited?**

Yes, it is!

According to GPCI, "On May 31, 2019, the National Commission for Certifying Agencies (NCCA) granted accreditation to the Grant Professionals Certification Institute (GPCI) and the GPC credential for demonstrating compliance with the NCCA Standards for the Accreditation of Certification Programs. The GPC is the first professional credential for individuals working in the grants field to be recognized by NCCA. The GPC credential, which has been in use since 2007, is the only experienced-based exam of its kind."
